Consent to processing of personal data

Hereby I, hereinafter referred to as the "Personal Data Subject", in compliance with the requirements of Federal Law No. 152-FL

"On Personal Data" dated July 27, 2006 (with amendments and additions) provide JSC " ABBA RUS ", the legal entity established and acting according to the legislation of the Russian Federation, OGRN 1034316534394, legal address: 30 Krylatskye Kholmy, building 9, Moscow, 121614, freely, at my will and in my interest with my consent to processing of my personal data specified during the registration by filling out a web feedback form on any of the following sites: filtrum.kz (hereinafter referred to as the "Site" or "Sites"), sent (completed) using the Site.

Under personal data I understand any information relating to me as a Personal Data Subject, including my last name, first name, patronymic, address, education, profession, contact data (phone, fax, e-mail, postal address), health state, which I provide due to the Site content, other information. Under the processing of personal data, I understand collection, systematization, accumulation, clarification, updating, modification, use, distribution, transfer, including transboundary, depersonalization, blocking, elimination, perpetual storage), and any other actions (operations) over personal data.

Processing of personal data of the Personal Data Subject is carried out solely for the purposes of registering and studying electronic requests, messages, letters by the Personal Information Subject, coming through the Sites, with subsequent answering to the Personal Data Subject that is exclusively informational in nature and not representing any medical advice, opinion, etc.

The date of issue of consent to the processing of personal data of the Personal Data Subject is the date of sending an electronic letter through a web form located on the Sites. Processing of personal data of the Personal Data Subject may be carried out with the help of automation and / or without the use of automation in accordance with the current legislation of the Russian Federation. JSC "ABBA RUS" takes the necessary legal, organizational and technical measures or ensures the implementation to protect personal data from unauthorized or accidental access, elimination, modification, blocking, copying, provision, distribution of personal data, as well as other illegal actions related to personal data, and also undertakes to keep the subject's personal data confidential. JSC "ABBA RUS" has the right to attract subcontractors for processing of personal data of the Personal Data Subject, as well as to transfer personal data for processing to its affiliated persons while ensuring the subcontractors and affiliated persons take appropriate obligations regarding the personal data confidentiality. JSC "ABBA RUS" has the right to send personal data of the Personal Data Subject to third parties engaged in medicine and pharmacology, research centers and external experts for the purpose of analyzing and researching the facts and content of messages sent by the Personal Data Subject through the web form on the Sites , subject to the accepting by such third parties of the relevant obligations regarding the personal data confidentiality.

Personal data is processed in JSC "ABBA RUS" until the receipt of personal data from the Personal Data Subject of the relevant written application for revocation of the Consent to process personal data or within 5 (five) years from the date of sending the Feedback Form. After that, personal data is eliminated within a period not exceeding 12 calendar months.

In case the personal data subject's or his/her representative`s withdrawal of consent to processing of personal data, JSC "ABBA RUS" is entitled to keep on processing the personal data without the personal data subject`s consent if there are reasons specified in clauses 2-11 of the section 1 of Article 6, Article 2, Article 10, and section 2 of Article 11 of the Federal Law dated 26.06.2006 No. 152-FL "On Personal Data".

I am aware that:

- This consent to processing of my personal data specified when sending a message via the web form on the Site (Sites) is valid for 5 (five) years from the date of sending the message via the web form filled on the Website (s) of JSC "ABBA RUS", and in case of early notifying JSC "ABBA RUS" about my personal data processing termination - from the date the notification delivered;
- 2. The consent may be withdrawn by me on the basis of a written statement drafted in an arbitrary form;
- 3. Provision of personal data of third parties without their consent entails responsibility in accordance with the current legislation of the Russian Federation.
